No cross entering will be permitted - riders must stay within the same division throughout the show and through all fair events.

- B. All riders must be properly attired.
- C. All riders, youth and adults, must wear a properly fitting equestrian helmet passing or surpassing current applicable ASTM/SEI (American Society for Testing and Materials/Safety Equipment Institute) standards with chin strap secured while mounted at any time/anywhere on the competition/event grounds.
- D. For our youth riders under 18 years of age, it is the responsibility of the parent, guardian, or trainer to see to it that the equestrian helmet worn complies with appropriate safety standards for protective headgear intended for equestrian use, and is properly fitted and in good condition. Riders over age 18 are responsible for their equestrian helmet complying with the standards. The Salem County 4-H Youth Development Program, Salem County 4-H Hoofbeats Planning Group, Show Committee, and officials are not responsible for checking equestrian helmet for such compliance.

- E. All riders must ride their own project animals. A project animal is defined as an animal that is registered in the County 4-H Office by July 1. Only animals registered by April 1 may be stalled at the fair and are eligible for year-end awards.
- F. A negative Coggins taken since 12 months must be presented when registering. Proof of yearly vaccinations is required.
- G. Only members who have filled out the 4-H Permission Form will be allowed to stay at the fairgrounds overnight.
- H. Ribbons 1-6 place (except for Cloverbud Exhibition Show)
- I. In the case of a tie for Championship, both members will be named champion. A coin will be flipped to determine who gets the trophy and who gets the ribbon on the day of the show. If the participants wish, another trophy and ribbon will be ordered.

- K. The riders are required to stay in the ring between Low Jumping and Western Pleasure classes, with the help of one groom to help with the tack change. A time limit is required and will be announced.
- L. The rider must have a number either on their back or on both sides of the saddle pad.
